## Comparison of the FCCP and the GSPP

Did you participate in the **Golden State Priority Project** (GSPP)? Are you curious how the **Fast Charge California Project** (FCCP) compares? Read on to understand the two projects.

The FCCP is the latest incentive project offered under the CALeVIP 2.0 block grant and has many similarities with the GSPP. However, given the FCCP's greater focus on site readiness and rapid deployment, there are several significant differences summarized in the table below.
