Are you eligible for Golden State Priority Project rebates?



CALeVIP's **Golden State Priority Project** provides rebates for direct current fast charger (DCFC) installations at eligible sites in California's eastern and central regions. Funding is available only for sites in **disadvantaged** or **low-income communities**, including land under control of federally recognized tribes. Disadvantaged or low-income communities are designated on the California Climate Investments **Priority Populations Map**.

Rebates may equal up to 50% of the purchase and installation costs, capped at \$55,000 (150 kW - 274.99 kW) or \$100,000 (275 kW+). **Eligible counties include**:

Site Requirements

- Must be located in disadvantaged community (DAC) or low-income community (LIC) census tracts.
- Must be well-lit, secure and in compliance with all federal, state and municipal laws, ordinances, rules, codes, standards and regulations.
- Must be publicly available 24 hours per day, 365 days a year.
- Cannot be located behind a fence or in a gated parking lot closed to the public after hours.
- Cannot have any time restrictions for availability to the public.
- Charging stations in stand-alone parking lots or parking garages not dedicated to a particular business or property must be accessible to the public at least 18 hours a day, seven days a week, excluding holidays.

How do you apply for the Golden State Priority Project?

We've made it easy and fast to apply for DC fast charger rebates through the Golden State Priority Project (GSPP). Applications may be submitted any time during the application window. Applications will be sorted into three readiness tiers based on documents submitted for the Permit Application Package and Utility Service Design Application Package. This selection process prioritizes funding for applicants who are further along in the permitting and utility design process.
